CREDIT TERMS

If the customer fails to pay pursuant to the terms of this agreement and Orange Crush, L.L.C. ("Orange Crush"), elects to take action to collect this account, the customer shall pay all costs incurred by Orange Crush, including, but not limited to: Attorneys' fees, collection agency fees, court cost, deposition and transcript costs, sheriff's fees, special process server fees, expert witness fees and bond cost. The customer assigns as security for any indebtedness incurred or to be incurred to Orange Crush under this account all of the customer's presently owned and existing and hereafter acquire and arising: accounts, accounts receivable, contract rights, chattel paper, equipment, inventory, and all proceeds of the foregoing collateral. Customer appoints any representative of Orange Crush as Customer's Attorney-in-fact to sign and file a UCC-I Financing Statement to perfect the security interest. This transaction shall be governed by the law of the State of Illinois, and jurisdiction and venue for the hearing for any matter in dispute shall be with the Circuit Court of Cook County, Illinois. Customer waives any right to a jury trial and any right to file a counter-claim in any action to enforce this agreement. At Orange Crush's sole discretion, any deposition will take place in Cook County.

The customer agrees that it shall not, either on its own or through a subcontractor, purchase any material, or rent any equipment or vehicle, if such activity is funded, either directly or indirectly, with City of Chicago, State of Illinois or Federal Funds.
